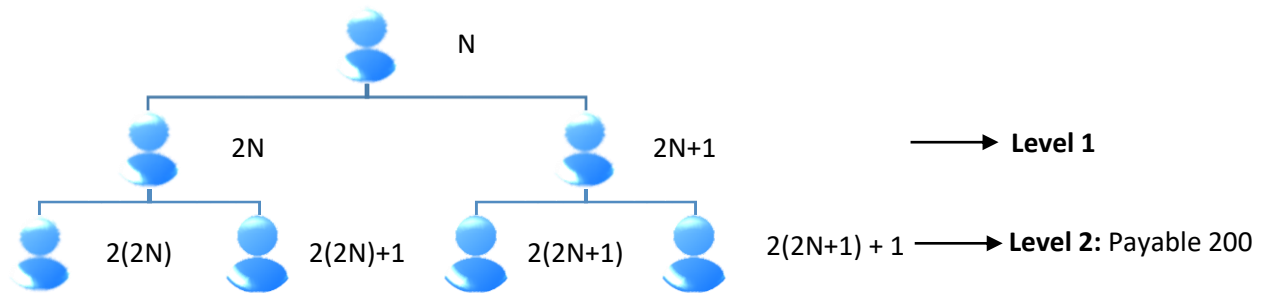

## 2. Pool Income

### 3. Reward income

Required BV are calculated considering the 1000 BV of active Direct ids .
